MUNICIPAL ORDINANCE NO. 23-66

AN ORDINANCE DECLARING A PORTION OF BALINTAWAK STREET, INTO A ONE-WAY-STREET.

Be it ordained by the Sangguniang Bayan of Polanco, Zamboanga del Norte, in a session, assembled that:

SECTION 1. Title. This Ordinance shall be called the Ordinance Declaring a Portion of Balintawak Street into a One-Way-Street.

SECTION 2. Declaration of Policy. It is the policy of the Municipality of Polanco, Zamboanga del Norte for its citizenry to have good education. Along this overarching principle comes the consideration that schools in the municipality shall at all times be safe learning environment for all our children.

SECTION 3. Scope and Application.

3.1 This Ordinance shall cover the Balintawak Street, particularly between the intersections of Balintawak – Pres. Macapagal Streets and Balintawak - Pres. M.L. Quezon Streets, right in front of Polanco Central School.

3.2 One-way-street flow shall be southward. Balintawak Street junction Quezon Street shall be a "No Entry" point to all kinds of vehicles all day long, all week long (24/7).

SECTION 4. Separability Clause. In the event that any part or provision of this Ordinance is held unconstitutional or invalid, other parts or provisions not otherwise affected shall remain in full force and effect.

SECTION 5. Repealing Clause. All other ordinances, resolutions, or provisions thereof, inconsistent herewith are hereby modified and/or repealed accordingly.

SECTION 6. Effectivity. This Ordinance shall take effect upon its approval.
