#### **MUNICIPAL ORDINANCE NO. 24-70**

AN ORDINANCE AMENDING MUNICIPAL ORDINANCE NO. 19-32, ENTITLED: "AN ORDINANCE BANNING/PROHIBITING ILLEGAL PARKING, THE SETTING UP AND/OR CONSTRUCTION OF ALL ILLEGAL STRUCTURES ON ALL SIDEWALKS, STREETS, NATIONAL HIGHWAYS, ROADS, BRIDGES, PARKS, AND OTHER PUBLIC PLACES WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF POLANCO, ZAMBOANGA DEL NORTE, PROVIDING PENALTIES FOR VIOLATION THEREOF AND FOR OTHER PURPOSES", PARTICULARLY SECTION VII, THEREOF.

Be it ordained by the Honorable Sangguniang Bayan of Polanco, Zamboanga del Norte, in session assembled, that:

**SECTION 1. -** Section VII of Municipal Ordinance No. 19-32 of the municipality of Polanco, Zamboanga del Norte, is hereby amended as follows:

Penalties - Any person found violating this ordinance shall suffer the following penalties to wit:

a.) First offense - P 200.00

b.) Second offense - P 500.00

c.) Third and succeeding offenses - P 1,000.00
