MUNICIPAL ORDINANCE NO. 24-72

AN ORDINANCE RECLASSIFYING A PORTION OF LOT TITLE NO. T-77188 SITUATED AT BARANGAY GUINLES, POLANCO, ZAMBOANGA DEL NORTE, WITH AN AREA OF 24,549 SQ. M. FROM AGRICULTURAL TO COMMERCIAL.

Be it ordained by the Honorable Sangguniang Bayan of Polanco, Zamboanga del Norte, in session assembled, that:

SECTION 1. – Short Title – This ordinance shall be known as the “Reclassification ordinance of particular/specific lands, from agricultural to commercial, in the Municipality of Polanco, Zamboanga del Norte”.

SECTION 2. Scope – This ordinance covers specifically a portion of Lot Title No. T-77188 situated at Barangay Guinles, Polanco, Zamboanga del Norte, with an area of 24,549 sq. m.

SECTION 3. Authority

- (1) Article III, Sec. 447, Paragraph 2 (viii), of Republic Act 7160, otherwise known as, the Local Government Code of 1991.
- (2) Rule VII, Article 38, paragraph (a) and (b) No. 2, of the Rules and Regulations implementing the Local Government Code of 1991.

SECTION 4. Limitation – Reclassified lands above-mentioned shall be used solely for the purpose intended as stated in this ordinance.

SECTION 5. Declaration of Intent to Conform with Law - This ordinance is subject to national laws, rules and regulations governing its subject matter.

SECTION 6. Repealing Clause – All ordinances, rules and regulations, or part thereof, in conflict with or inconsistent with any provisions of this Ordinance are hereby repealed or modified accordingly.


SECTION 7. Separability Clause – If for any reason, any section or provision of this Ordinance or any part thereof, or the application of such section, provision or portion is declared invalid or unconstitutional, the remaining parts thereof shall not be affected by such declaration.

SECTION 8. Effectivity – This Ordinance shall take effect after fifteen (15) days posting in three (3) conspicuous places of this municipality.
